





Industrial water treatment:

membrane separation technology and equipment, Industrial circulating cooling water treatment equipment, Boiler make-up water treatment, reclaimed water technology and equipment, Water saving and waste water recycling application equipment, MVR evaporator, desalter, Dosing and disinfection equipment, ozone equipment, crystallizer, heat-exchange equipment, centrifugal machine, filter plant, sludge treatment equipment, water quality monitoring and process control, water treatment materials and pharmacy, chemical water treatments, biological water treatment, heavy metal removal treatment, etc.

Waste gas technology:

waste gas treatment equipment, adsorption equipment, oil fume purifier, welding smoke purifier, chlorine leakage absorption and neutralization device, organic waste gas purification equipment, deodorization equipment and system, waste gas recycling equipment, clean coal and clean combustion technology equipment.

Atmospheric controlling treatment of industrial smoke dust:

desulfurization and denitrification, dust removal technology and equipment, VOC disposal, dust remover, filter material, filter-bag, ash conveying device, electric control gear, flushing valve assy, detection and analysis instrument of gas pollution and tail gas, detection sensors of atmosphere, exhaust gas, lampblack, flue gas and hazardous gas, gas alarm, hazardous gas detection equipment and other related equipment.

Indoor air purification:

industrial plant air purification equipment and system, fume purification equipment and system, industrial plant ventilation system, photocatalyst, etc.

Solid waste disposal equipment:

waste collection, classification, compression technology and transfer vehicle, equipment of waste landfill, incineration, biochemical treatment, technology of detecting, monitoring, recycling and reusing, waste, waste fermentation, old metal, tires, plastics and other recycling machine and technology, solid wastes integrated utilization equipment and technologies.

Energy saving equipment and resources comprehensive utilization equipment:

frequency converter, energy-efficient equipment, noise control equipment, ventilating device, utilization and recycle of residual heat, residual energy and residual pressure, cogeneration equipment, energy saving of coal-fired boiler, biomass energy, waste recycling.


